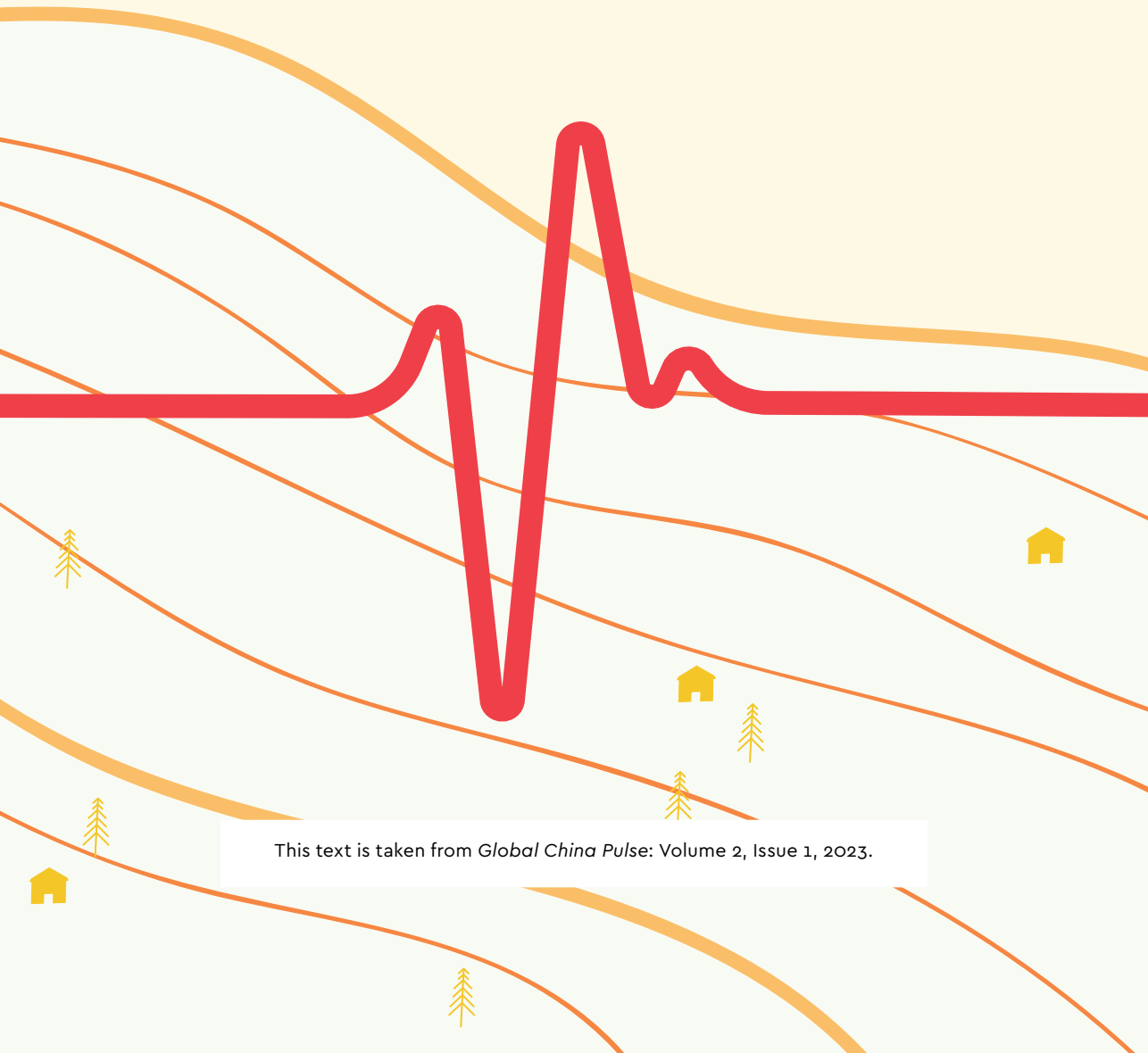

CONTRIBUTORS

Omolade ADUNBI is a political and environmental anthropologist, Professor of Anthropology and Afroamerican and African Studies, Professor of Law (courtesy), and the Director of the African Studies Centre at the University of Michigan, Ann Arbor. His research explores issues related to governance, infrastructures of extraction, environmental politics and rights, power, violence, culture, transnational institutions, multinational corporations, and the postcolonial state. He is the author of *Oil Wealth and Insurgency in Nigeria* (Indiana University Press, 2015) and *Enclaves of Exception: Special Economic Zones and Extractive Practices in Nigeria* (Indiana University Press, 2022).

Elia APOSTOLOPOULOU is a geographer and a political ecologist. She is currently a senior researcher at ICTA, Autonomous University of Barcelona, where she leads a research line on 'Planetary Urban Infrastructures' at the Barcelona Lab for Urban Environmental Justice and Sustainability. Elia is also a Senior Associate at the Cambridge Institute for Sustainability Leadership at the University of Cambridge and an editor at *Dialogues in Human Geography*.

Emily BAUM is an Associate Professor of History at the University of California, Irvine, and the author of *The Invention of Madness: State, Society, and the Insane in Modern China* (University of Chicago Press, 2018). She is currently completing two books: *Needed: The Americanization of Acupuncture*, and an edited volume (with Albert Wu), *Uncanny Beliefs: Superstition in Modern Chinese History*.

Monica DeHART is a Distinguished Professor of Anthropology, Latin American Studies, and Global Development Studies at the University of Puget Sound, Washington State. She has been studying the cultural politics of economic development in Central America for more than 25 years. Her most recent book, *Transpacific Developments: The Politics of Multiple Chinas in Central America* (Cornell University Press, 2021), builds on ethnographic research in Costa Rica, Nicaragua, and Guatemala to analyse the different forms and meanings China has taken in the region's development politics.

Jessica DiCARLO is an Assistant Professor in Geography at the University of Utah. She received her PhD from the University of Colorado Boulder and worked at the University of British Columbia. She contributes to debates on global China's role in shaping development and resource politics, particularly across Asia. Her research has appeared in *Transactions of the Institute of British Geographers*, *Geopolitics*, *Geoforum*, *Ecology and Society*, and *Ambio*. She is the co-editor of *The Rise of the Infrastructure State* (Bristol University Press, 2022).

Miriam DRIESSEN is an anthropologist by training. Her work explores Chinese-led development from below, looking at issues such as migration, labour, gender and sexuality, language, and, more recently, law. She has published in various journals including *American Anthropologist*, *The China Quarterly*, and *African Affairs* and is the author of *Tales of Hope, Tastes of Bitterness: Chinese Road Builders in Ethiopia* (Hong Kong University Press, 2019).

Han CHENG is a Max Weber Foundation Research Fellow at the Asia Research Institute, National University of Singapore. His research explores changes in global development financing, ideologies, norms, and partnerships, with a particular focus on the role of China and other ‘rising powers’. Han holds a PhD in geography from the University of Cambridge and worked in policy research and investigative journalism before joining academia.

Elsa FAN is a medical anthropologist who studies how global health knowledge and practices travel across social and cultural contexts. Her book *Commodities of Care: The Business of HIV Testing in China* (University of Minnesota Press, 2021) examines how HIV testing unfolded in unexpected ways for men who have sex with men in China. She has written about performance-based financing, metrics, and evidence-based global public health. She is currently an Associate Professor of Anthropology at Webster University, Missouri.

Ivan FRANCESCHINI is a Senior Lecturer in Chinese Studies at the University of Botswana. His current research focuses on Global China as seen from the vantage point of Cambodia. His latest books include *Xinjiang Year Zero* (ANU Press, 2022), *Proletarian China: A Century of Chinese Labour* (Verso Books, 2022), and *Global China as Method* (Cambridge University Press, 2022). With Tommaso Facchin, he co-directed the documentaries *Dreamwork China* (2011) and *Boramey: Ghosts in the Factory* (2021). He is a founder and Chief Editor of the *Made in China Journal*, *The People’s Map of Global China*, and *Global China Pulse*.

Yunxiang GAO (高云翔) is Professor of History at Toronto Metropolitan University. Her research focuses primarily on transpacific cultural history through a multilingual approach. She has written two books: *Arise Africa, Roar China: Black and Chinese Citizens of the World in the Twentieth Century* (University of North Carolina Press, 2021) and *Sporting Gender: Women Athletes and Celebrity-Making during China’s National Crisis, 1931–1945* (University of British Columbia Press, 2013). Gao is currently finishing a biography tentatively titled ‘Soo Yong: A Hollywood Actress and Cosmopolitan of the Asian Diasporas’.

Yidong GONG is an Assistant Professor of Anthropology at New College of Florida, a public liberal arts college in the United States with a distinctive academic program that emphasises individualised learning. He studies how medical expertise and ethics influence biopolitics in transnational health care, and particularly their convergence and friction in Africa. His current book project examines China's longstanding medical programs in South Sudan, which offer an alternative to the prevailing values of medical humanitarianism in regions marked by crisis or conflict.

Marta HANSON is an independent scholar who writes about the history of medicine in China, public health in East Asia, and connected Sino-European medical history. She was associate professor of East Asian medical history in the History of Medicine Department, Johns Hopkins University (2004–21), and Assistant Professor of late imperial Chinese history at the University of California, San Diego (1997–2004). She is the author of *Speaking of Epidemics in Chinese Medicine: Disease and the Geographic Imagination in Late Imperial China* (Routledge, 2011).

Arthur KAUFMAN is an editor at *China Digital Times*, and an editorial assistant for the *Made in China Journal* and *Global China Pulse* journal. He graduated from the dual master's degree program between Sciences Po and Peking University, where he studied human rights and international relations. Previously, he was a Writing and Speaking Fellow at NYU Shanghai.

Jay KE-SCHUTTE is a semiotician and ethnographer. Their work covers themes of communication and alterity in the human management of temporality, including the musical construction of sensory worlds; the terraformation of environments; the chrono-politics of race and intersectionality; as well as the interpersonal maintenance of historical and linguistic infrastructures. They are an assistant professor at Zhejiang University in China.

Ling LI is a PhD candidate at Ca' Foscari University of Venice, a project manager at Humanity Research Consultancy, and regional consultant on Southeast and East Asia for the Centre for the Study of International Slavery at the University of Liverpool. Since early 2022, she has been intensively engaged with survivors of the scam compounds in Cambodia, interacting with local and international civil society organisations to bring them relief and supporting them with repatriation.

Michael Shi-yung LIU is a Distinguished Professor at Shanghai Jiao Tong University and an affiliate of the Asian Studies Center, University of Pittsburgh. He formerly worked at the Academia Sinica in Taiwan. He writes about the history of modern medicine in East Asia, Japanese colonial medicine, and East Asian environmental history. He is the author of *Prescribing Colonization: The Role of Medical Practice and Policy in Japan-Ruled Taiwan* (Association for Asian Studies, 2009). His book in Chinese on modern medicine in East Asian societies will be published by the end of 2023.

Jordan LYNTON COX is an Assistant Professor of Anthropology in the Department of Anthropology and Middle Eastern Studies at Mississippi State University. Her research examines Chinese civic/cultural organisations in Jamaica, as well as the spatial, cultural, political, and economic contestations that occur because of more expansive investment in the Caribbean by the People's Republic of China. She is a member of the editorial board of *The People's Map of Global China* and *Global China Pulse*.

Igor ROGELJA is a Lecturer in Global Politics at University College London, where he works mostly on international infrastructure and Chinese politics. He was previously based at the Lau China Institute at King's College London and completed his doctoral studies at SOAS, University of London. He is interested in the politics of space and is involved in several research projects examining the effects of Chinese infrastructural investment in the so-called Belt and Road Initiative.

Wayne SOON is an Associate Professor in the Program of the History of Medicine in the Department of Surgery and the Program of History of Science, Medicine, and Technology at the University of Minnesota. He is the author of *Global Medicine in China: A Diasporic History* (Stanford University Press, 2020). Soon has published articles on the history of medicine in China and Taiwan in academic journals and news magazines. His current research projects are centred on the history of health insurance and medical practices in postwar China and Taiwan and the transpacific history of Severe Acute Respiratory Syndrome (SARS) and Covid-19.

Cecilia SPRINGER is a Non-Resident Research Fellow with the Global China Initiative at the Boston University Global Development Policy Center. She is a Principal at Global Efficiency Intelligence, leading research on industrial decarbonisation. Previously, she served as the inaugural Assistant Director of the Global China Initiative. Her interdisciplinary research focuses on the environmental impacts of China's overseas investment, policymaking processes within China and industrial decarbonisation. She was a Postdoctoral Fellow at the Harvard Kennedy School and earned her MS and PhD from the Energy and Resources Group at the University of California, Berkeley and a BS in Environmental Science from Brown University.

Emily WILCOX is Associate Professor and Director of Chinese Studies at William & Mary, Virginia. She is the author of *Revolutionary Bodies: Chinese Dance and the Socialist Legacy* (winner of the 2019 de la Torre Bueno Prize® from the Dance Studies Association), co-editor of *Corporeal Politics: Dancing East Asia* (University of Michigan Press, 2020) and *Inter-Asia in Motion: Dance as Method* (Routledge, 2023), and co-creator of the University of Michigan Chinese Dance Collection. Her current research examines dance and leftist internationalism during the Cold War.

Wei YE is a doctoral candidate in anthropology at the University of Minnesota, Twin Cities. Her dissertation researches the global making of a Chinese medicine, *ejiao* (donkey-hide gelatine), by tracing the Africa–China donkey-hide commodity chain. She is also the co-founder of the Chinese anthropological platform *TyingKnots* (结绳志).

Pei-hua YU is a senior consultant specializing in Chinese overseas investment and clean energy transition in the Global South. She was an award-winning journalist whose reportage elucidating the dynamics surrounding foreign direct investments in Asia's frontier and emerging economies triggered vigorous discussion in China and internationally. Her work was published by the *South China Morning Post*, *The People's Map of Global China*, and *Phoenix Weekly*, among others.

Hong ZHANG is a China Public Policy Postdoctoral Fellow at the Harvard Ash Center for Democratic Governance and Innovation. Her research interests include China's political economy, international development cooperation and foreign aid, and the global expansion of Chinese state-owned enterprises.

Meng ZHANG is a medical historian and Assistant Professor at the Department of History of Science, Technology, and Medicine, Peking University, China. He earned his doctoral degree from the Department of History, Peking University, in 2018. His research interests lie in the intersection of medicine, colonialism, and the state in modern Chinese history. He is now working on a book about Japanese-trained Chinese physicians and the formation of state medicine in modern China.

Keren ZHU is a Global China Postdoctoral Research Fellow at the Boston University Global Development Policy Center. She holds a PhD in Policy Analysis from the Pardee RAND Graduate School. Her research focuses on the Belt and Road Initiative (BRI), global infrastructure, and sustainable development. She worked on BRI international cooperation and policy advisory in China from 2015 to 2017.

Dongxin ZOU is an Assistant Professor in History of Science at the Hong Kong Polytechnic University who specialises in modern Chinese history. Her research focuses on the history of medicine, health technology, and the transnational networks of material circulation and knowledge production in the Global South. She is currently writing a book that explores the history of Chinese medical missions to postcolonial Algeria, focusing on the exchange of technologies, drugs, and medical practices.
